Stacey Crombie - The Claimant

Stacey has been working at Simon Taylor Cutlery Limited since 27th July 2009. She was employed as a Shift Supervisor and worked on the same packing line until December 2012.

In December 2012 she was asked to cover for another Shift
Supervisor during maternity leave and was told this would only be for a short period of time. It meant Stacey having an additional workload and working on an unfamiliar production line.

Some training was provided, but Stacey made mistakes which meant the company incurred additional costs and loss of credibility with a major client.

At the same time Stacey was having difficulties with her daughter and was finding it difficult to sleep.

A Performance Improvement Plan was started. Stacey found it all too much and resigned.

She is now taking the company to an Employment Tribunal claiming compensation for Constructive Unfair Dismissal.
